FCCU is pleased to offer our special Holiday Helper loan again this year! This is a \$500.00 loan to be paid over 9 months at 16.90%, with a monthly payment as low as \$59.55. There will be NO CREDIT QUALIFYING! In order to take advantage of the Holiday Helper Loan you must:

- ▶ Be a primary member of FCCU for at least six months
- ► Have all accounts in good standing
- ▶ Be at least 18 years of age
- ▶ Be on your current job for one year

If you meet the above criteria, you pay a \$30.00 application fee, and complete a special short application, that's it! Not only are we helping you with your holiday cash, this is a tremendous opportunity to establish or reestablish credit.\*
