

#### The Learning Corner

Have you ever received a call that you knew the number but did not recognize the voice or the name of who answered? FCCU is here to give some insight on this...

A scam that happens is fraudsters pose as financial institutions and give calls out to gain your information. They even have the correct phone number for you to see if you have caller ID! They are wanting to gain the password to be able to access your online account, and if they are able to obtain access they will change the contact information along with the passwords to the account.

This scam may also be executed through text messaging. The fraudster will send account alerts to members via text message that will appear to come from the financial institution and will be warning the member of suspicious activity. If a response message is sent, the fraudster then calls stating that they are verifying the transaction in question and that the member must provide a code over the phone. The fraudster will then attempt a text transaction that triggers a 2-step authentication password process. Once the password is verified through text, the fraudster immediately goes in and logs into the member's account and transfer funds.

# Funds Availability Regulation (C Changes

Effective July 1st, 2020, we are increasing the amount we make available for withdrawal by checks subject to next day availability from \$200 to \$225. In addition, the amount available for withdrawal on exception holds for large deposits and new accounts is increasing from \$5,000.00 to \$5,525.00
